As part of District 103’s strategic focus to optimize current space and plan for needs at the schools, and as approved by the Lincolnshire-Prairie View District 103 Board of Education:

- Construction began in early February 2017, on additions and renovations to Laura B. Sprague and Half Day Schools with completion before school starts on August 28, 2017.
- Transition plans were also made for 5<sup>th</sup> grade to move from Daniel Wright Junior High School to Half Day School with the beginning of the 2017-2018 school year. This provides an age-appropriate building configuration for students in grades 3-5 and relieves capacity constraints at Daniel Wright.

Lincolnshire-Prairie View School District 103 is a nationally recognized elementary district for excellence in education and is located in Lake County, Illinois. The District includes the following schools: Laura B. Sprague School for students in Early Childhood-grade 2; Half Day School for students in grades 3-5; and Daniel Wright Junior High School for students in grades 6-8.
